Three prompts will be given prior to the end of each of the first three units. The papers will be due at the beginning of the next unit. Out of the three prompts, you are expected to pick **TWO** to complete, and you should submit them to the appropriate folder on Blackboard, which will scan the files for plagiarism. Each paper should be approximately four pages.

Please note again the University's plagiarism policy, and also be aware that, per the rubric, a missing thesis and/or conclusion will result in an automatic drop to an F.
